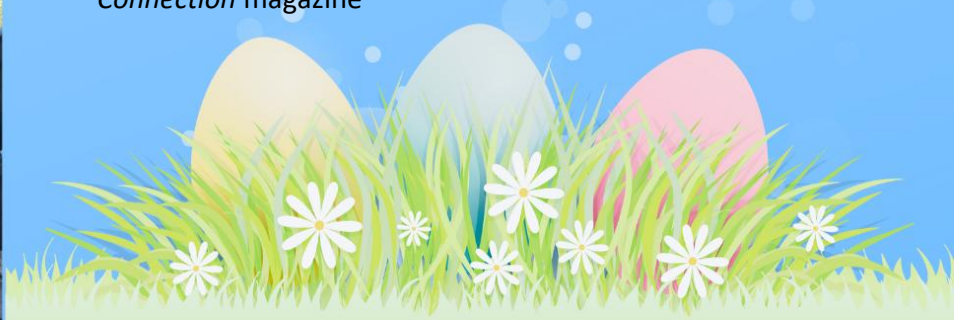

To ensure your organization receives all promotional opportunities and benefits, sponsorship payment and your logo in a high-resolution PNG format must be received forty-five (45) days prior to event date. Sponsorship payments will be invoiced by the City of Richland Hills following your confirmation and must be paid within thirty (30) days of invoice. Contributions to a city are tax deductible under Section 16, USCA 170.
